Policy of Research & Innovation Promotion (Version-II)

Preamble

The Policy of Research and innovation promotion of Geeta University encourages faculty members for their professional growth. With the introduction of NIRF ranking at National level, QS Star Rating at International level and considering the recommendations of NAAC accreditation, the emphasis is given to publish research papers in WOS/SCI/SCIE/ABDC Journals/ Scopus database. Keeping the UGC guidelines in mind, the policy is developed in the interest of the Geeta University which will not only improve the research credentials of the University but also the credentials of faculty members as well. This will help all faculty members to contribute towards research, innovation, publication and other areas for the benefit of all the stakeholders.

Definitions

The University uses a broad definition of what constitutes Research & innovation promotions. Its essentials features are:

Research & Innovation is professional work undertaken by faculty member of university in multidisciplinary field of interest, for which minimum performance points has to be undertaken by each & every faculty. It may result in generation of research publications, IPRs, Research projects/Funding, consultancies.

Objectives

The University is committed to disseminating its research as widely as possible to create maximum impact, and support its faculty members in making their research outputs available through open access.

Research Facilitation to Faculty members

It is the need of the hour to make it mandatory for all faculty members to contribute towards research and other activities at all levels so as to earn minimum performance points based on listed parameters. This will help them to get annual increments/allowance /financial support/grants from the organization. However, if someone is not able to earn minimum performance points as per their cadre limit, he/she will be given another six months of improvement. Thereafter, such faculty members shall be treated as non-performer and annual increment will not be considered for the faculty members who could not achieve the minimum performance points till they achieve the minimum performance criteria.

The details of minimum performance points to be earned by faculty members in one academic year are given below: -

The performance point will be calculated on the basis of following parameters in one academic year (July to June) and one can earn multiple points under each category to achieve minimum performance points every year.

And in case of the IPR, Geeta University shall be applicant and individuals shall be innovators. The manuscript/ chapter/ edited books or IPR will not be considered for benefits claims without the above affiliations.
- 2. University will consider the incentive for only Scopus/ WOS/ SCIE/ ABDC/ SCI Indexed journals as mentioned Table 3.

Conditions to Claim the Incentives:

- The incentive amount of publications will be divided among the total number of authors.
- For Scopus-indexed conference proceedings category, either registration fee (maximum Rs. 5,000) or incentive may be claimed. Registration fee will be reimbursed after the indexing of the paper in the Scopus Data base only.
- If the publication belongs to UG. PG. and PhD project/thesis/research work, then the student/ Research Scholar must be first author and guide/mentor shall be corresponding author of publication.
- This shall be applicable only to the papers published under "Geeta University, Panipat 132145, Haryana, India" affiliation.
